PART 6:

ACCESS PRICING

6.1 Indicative access prices

This section provides details of Southern Water's indicative access prices for 2023-24. These indicative prices are published for information purposes only. Applicants should note that access prices for any given agreement will depend on the precise details of the access arrangements and may differ substantially from the prices shown here.

These indicative access prices reflect the information from Ofwat's 2019 periodic review of price limits and 2024 draft Water Resources Management Plan (dWRMP). In considering specific access price applications we will, as appropriate, take account of all relevant available information, in calculating the appropriate price in line with our obligations under statute and competition law.

Wholesale charges shown for future years are forecasts only. Actual charges are set annually and may differ from those shown here.

6.1.1 Wholesale prices

Wholesale prices are published in our Wholesale Charges 2023-24 charging booklet.

This is consistent with the approach set out in Ofwat's letter to water companies, dated 18 August 2014, 'The costs principle and access pricing – companies operating wholly or mainly in England'.

A single wholesale price applies to the whole of the Southern Water region.

6.1.2 Indicative combined supply access prices

Tables 6.1.2(1)-(14) below provide indicative prices for combined supply for each of Southern Water's water resource zones. Prices are shown for access in 2023-24 to 2027-28. The indicative prices are based on our published wholesale charges, with a deduction for costs avoided.

Table 6.1.3 shows the forecast supply demand deficit for each of our fourteen water resource zones, as set out in our draft 2024 dWRMP, before investment by Southern Water or input of water by a licensee.

In both cases these indicative prices are based on Southern Water's Water draft Resources Management Plan, dated October 2023. Any application for a case-specific access price will use the latest available data.

To simplify the calculation of these indicative prices a number of assumptions have been made. In particular it is assumed that:

- (i) all inputs of water by the Licensee are spread evenly over the course of the year;
- (ii) as a result of the access agreement Southern Water will be able to reduce the output from its own water sources in the resource zone. The assumed reduction in operating costs resulting from this reduction is based on the most expensive source in the water resource zone:
- (iii) where capital expenditure is deferred as a result of access, depreciable capital expenditure and the cost of capital is equal to that used by in the PR19 final determination:
- (iv) the licensee's supply is introduced at a point in the network just after a water treatment works. Thus no allowance is made within these prices for changes in costs associated with the distribution network.

The access prices charged in any particular case will depend very heavily on the precise details of the supply arrangements including, amongst other things, the point of entry and exit, the volume of water introduced and the length of the access agreement.

Combined supply access prices are published for 5 Ml/a, 50 Ml/a and 100 Ml/a customers.

We provide around 560 million litres of water per day. In the future, if we do nothing there will be a shortfall in water supplies. We may need an extra 238 million litres of water per day by 2030. This is because there are three main pressures on our water supplies – a growing population, climate change and the need to protect and improve our environment.

The biggest challenge of these is how to sustainably provide water. This means that we will need to reduce how much water we abstract from some of our existing, more sensitive sources and replace them with new ones. We would therefore welcome any additional sources of water to ensure we have sufficient supply for our customers. Even with any additional water resources, it is unlikely that we would be able to defer any schemes within our investment programme which is needed to ensure a resilient and sustainable supply of water in the South East.
